- **President**

 - Current bank account 5,773.83
 - the money from table talks was not transferred to the managed fund so we will move 3,602.35 over leaving us with 2,171.48
 - Do we have to cover the deposit for white rose
 - not sure will reach out to Brother Scaglione
 - As well as table talks
 - we should be fine because tickets and table talks both pretty much pay for themselves
 - Deposit for white rose is only 500 dollars so we are fine
 - Budget
 - scholarship is going to come from the managed fund so we just have to vote on it and not have to budget it.

- Don't forget when you create the budget to account for the bank fees
- then we have the nationals dues of 200
- we still have to reimburse Brother Van Duesen and Brother D'Ambrosia for last year's convention
- It's hard to keep track of where everyone's dues are
- suggest we do not have a delegate stipend for this year since it seems like it's pretty local for us
- if we do not pay for the alumni brunch too that's less money that we have to spend
- Next meeting we can have a real chart of expenses so that we can talk about it
- We need to vote to pass the 460 dollar budget
- also want to keep dues at 30 a year and 100 for four years
- Motion to pass the 2025 budget as described
 - passes unanimously
- Will reach out to more people to pay dues next year
- Create a contact list since we don't all have everyone's contact information
- **Secretary**
 - Brother Booth apologizes for not being good about the minutes but the Website has been crashing everytime she tries to upload them
 - Talk to Brother Scaglione about getting minutes on greek track
 - should already have access
 - Awesome Brother Booth will attempt to upload them to Greek Track and let everyone know how it goes
